The term of office of the above-named personnel shall expire one (1) year upon its execution unless sooner removed, has resigned/retired, transferred or re-assigned.

Moreover, the members of said committee are entitled to a monthly honorarium which shall not exceed twenty-five percent (25%) of their respective basic salary in accordance with DBM Circular No. 2004-5A. However, such claim shall be on a pro rata basis depending on their attendance on various BAC deliberations and proceedings.

On the other hand, the members of the Technical Working Group (TWG) shall perform their functions on an "on call basis" depending on their technical expertise required in which case a memorandum inviting them shall be issued to such effect.

All personnel designated herein shall be on a "jury duty" type of assignment. The term "jury duty" shall be understood to mean that BAC proceedings/assignments shall be given utmost priority over all other duties and responsibilities.

This order shall take effect immediately and supersedes all issuances inconsistent herewith.
