- I. 14 Units Coagulating Tank
Size: 42" x 90" x 2"
Materials for Construction: Fabricated from gauge 18 stainless Steel Sheet Grade 304 with round bar
With Round bar reinforcements
- II. 7 Units Slab Slicer
Manual Crank Type
Fabricate from circular saw blade with counter rubber roll
Compete with 1" diameter cold rolled staff mounted on pillow block bearings on angular frame including wooden feeding table and manual crank.
- III. Double Roller Rubber Sheeter
18" Long Rollers
Fabricated from black iron pipe schedule 80" x 4" diameter on 1 ½ inches drive shaft with heavy duty spur gear drive 360 chain sprocket and belt pulley combination speed reducer.
Drive by a 2 HP electric Motor 220 V/1 phase/60Hz
- IV. Smoke House Dryer
Size: 8'L x 8'W x 8'H
Fabricated from 2" x ¼ " angular frame with hardiflex wall and GI corrugated Ga 26 roofing complete with galvanized pipe and biomass stove as heat source and smoke (Auto fed with blower 1 HP electric motor)
- V. Manual Baling Press
Fabricated from 4mm thick mild steel plate with hydraulic jack press




