Whereas, a public bidding was conducted last November 2, 2016 at 9:00 am in the DA12 Conference Room, Koronadal City. It was presided by the BAC Chairman.

Whereas, there were two (2) bidders who submitted its letter of intent and sealed bid for the **Establishment of Multiplier Farms in Different LGUs of Region XII** with the **Approved Budget for the Contract (ABC) of Four Million Six Hundred Thirty-Six Thousand One Hundred Eighty-Six Pesos and 68/100 (Php4,636,186.68)**, i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Isulan ECT Construction and General Merchandise, Inc.** in the amount of **Four Million Two Hundred Eighty-Three Thousand One Hundred Three Pesos and 28/100 (Php4,283,103.28)** met the minimum requirements and was determined as the **Lowest Calculated Bid**. Therefore, subjected for Post-Qualification;

Whereas, per post-qualification of all the submitted documents of **Isulan ECT Construction and General Merchandise, Inc.** it was determined that the latter was technically, legally and financially eligible and its bid was declared the **Lowest Calculated Responsive Bid**;


Whereas, Section 34.4 Rule X of RA 9184 states that *"If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all criteria for post-qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower...xxx"*

Whereas, the bid amount submitted by **Isulan ECT Construction and General Merchandise, Inc.** which is advantageous to the government is **Four Million Two Hundred Eighty-Three Thousand One Hundred Three Pesos and 28/100 (Php4,283,103.28)**.






