

Whereas, the Department of Agriculture - Regional Field Office No. 12, Koronadal City under the SOCSKSARGEN Food Security Program CY 2015 Fund has a project, i.e.; **Concreting of Purok 1-Purok 2 FMR (Extension) in Brgy. Bulacan, Makilala, North Cotabato** with the Approved Budget for the Contract (ABC) of **One Million Two Hundred Thirty-Two Thousand Three Hundred Twenty-One Pesos and 45/100 Only (Php1,232,321.45);**

Whereas, a public bidding for the **Concreting of Purok 1-Purok 2 FMR (Extension) in Brgy. Bulacan, Makilala, North Cotabato** with the Approved Budget for the Contract (ABC) of **One Million Two Hundred Thirty-Two Thousand Three Hundred Twenty-One Pesos and 45/100 Only (Php1,232,321.45)** was scheduled last October 19, 2016 - 9:00AM at DA-12 Conference Room (2nd Floor), Brgy. Carpenter Hill, Koronadal City. It was presided by the BAC Chairman;

Whereas, the project shall be on **85/15** scheme wherein the **eighty-five percent (85%)** cost of the project shall be charged to **DA-RFO 12 SOCSKSARGEN Food Security Program CY 2016 Fund** and the **fifteen percent (15%)** cost shall be the **Provincial Local Government Unit (PLGU) of North Cotabato's counterpart** as shown below:

DA-12 SOCSKSARGEN Food Security Program (85%)	: Php1,047,473.23
PLGU North Cotabato (15%)	: 184,848.22
Total Approved Budget for the Contract (ABC)	: Php1,232,321.45

Whereas, there was only one (1) bidder who submitted its letter of intent and sealed bids for the **Concreting of Purok 1–Purok 2 FMR (Extension) in Brgy. Bulacanon, Makilala, North Cotabato**, namely:

Whereas, after the thorough deliberation of the Bids and Awards Committee (BAC) based on the evaluation and post-qualification reports of the Technical Working Group (TWG), it was found that **Pader Construction and Supply** met the minimum requirements of the Procuring Entity and was determined as the bidder who submitted the **Single Calculated and Responsive Bid**;

Whereas, Section 36 (a), Rule X of RA 9184 states that *“A single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances:*

- a) *If after advertisement, only one prospective bidder submits an LOI and/or applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; or Xxx”*

WHEREFORE, premises considered, it is hereby RESOLVED to recommend to the Head of the Procuring Entity (HOPE) that the **Concreting of Purok 1–Purok 2 FMR (Extension) in Brgy. Bulacanon, Makilala, North Cotabato** in the amount of **One Million Two Hundred Twenty-Two Thousand One Hundred Eight Pesos and 16/100 Only (Php1,222,108.16)** be awarded to **Pader Construction and Supply** as the bidder who submitted the **Single Calculated and Responsive Bid**.
