**WHEREAS**, a public bidding was conducted on 20 June 2017, 9:00 in the morning at DA XII Conference Room, Barangay Carpenter Hill, Koronadal City for the procurement of project entitled **Supply and Delivery of 10 Units Multi Cultivator with Implements** with an **Approved Budget for the Contract (ABC) of Two Million Five Hundred Thousand Pesos (Php2,500,000.00)**.

**WHEREAS**, there were two (2) bidders who submitted their letters of intent and sealed bids for the above-described project, to wit;

**WHEREAS**, during the Bid Evaluation Process, the BAC including its Technical Working Group (TWG) found out that the bid submitted by **ONE DRAGON MARKETING** in the amount of **Two Million Forty-Five Thousand Pesos (Php2,045,000.00)** has met the minimum

requirements and was determined as the **Lowest Calculated Bid**. Therefore, subjected to Post-Qualification;

**WHEREAS**, per the conduct of post-qualification process of all the submitted documents, it was determined that **ONE DRAGON MARKETING** was post disqualified due to non-compliance for the following reasons;

**WHEREAS**, Section 34.6, Rule X of RA 9184 states that "Immediately after the BAC has notified the first bidder of its post disqualification, and notwithstanding any pending request for reconsideration thereof, the BAC shall initiate and complete the same post-qualification process on the bidder with the second Lowest Calculated/Highest Rated Bid. If the second bidder passes the post-qualification, and provided that the request for consideration of the first bidder has been denied, the second bidder shall be post-qualified as the bidder with the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid."

**WHEREAS**, no Motion for Reconsideration was filed by **ONE DRAGON MARKETING**;
