Whereas, a public bidding was conducted last November 15, 2016 at 9:00 am in the DA-12 Conference Room, Brgy. Carpenter Hill, Koronadal City. It was presided by the BAC Chairman.

Whereas, there were three (3) bidders who submitted its letters of intent and sealed bids for the **Supply and Delivery of Ten (10) units Hand Tractor (Power Tiller)** with the **Approved Budget for the Contract (ABC)** of **One Million Two Hundred Thousand Pesos (Php1,200,000.00)**, i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Megamight Enterprises** in the amount of **One Million One Hundred Twenty-Eight Thousand Pesos (Php1,128,000.00)** met the minimum requirements and was determined as the **Lowest Calculated Bid**. Therefore, subjected for Post-Qualification;

Whereas, per post-qualification of all the submitted documents of **Megamight Enterprises**, it was determined that the latter was technically, legally and financially eligible and its bid was declared the **Lowest Calculated Responsive Bid**;



Whereas, the bid amount submitted by **Megamight Enterprises**, which is advantageous to the government is **One Million One Hundred Twenty-Eight Thousand Pesos (Php1,128,000.00)**;

WHEREFORE, premises considered, it is hereby **RESOLVED** to recommend to the Head of the Procuring Entity (HOPE) that the **Supply and Delivery of Ten (10) units Hand Tractor (Power Tiller)** in the amount of **One Million One Hundred Twenty-Eight Thousand Pesos (Php1,128,000.00)** being the bidder with the **Lowest Calculated Responsive Bid**, be awarded in favor of **Megamight Enterprises**.


