WHEREAS, a public bidding was conducted on August 2, 2017 9:00 o'clock in the morning at DA 12 Conference Room, Koronadal City, South Cotabato, for the project entitled **Construction of Eight (8) units Greenhouse particularly Line Item No.3: Construction of Two (2) units Greenhouse in DA - Amas RES, Kidapawan, North Cotabato** with an **Approved Budget for the Contract (ABC) of Two Million Two Hundred Forty-One Thousand Five Hundred Sixty-Six Pesos and 28/100 (Php2,241,566.28)**.

WHEREAS, during the Bid Evaluation Process, the BAC including its Technical Working Group (TWG) found out that the bid submitted by **RNS Construction and Engineering** in the amount of **One Million Seven Hundred Nineteen Thousand Five Hundred Sixty-Eight Pesos and 28/100 (Php1,719,568.28)** has met the minimum requirements and was determined as the **Lowest Calculated Bid**. Therefore, subjected for Post-Qualification;

WHEREAS, per the conduct of post-qualification process of all the submitted documents, it was determined that **RNS Construction and Engineering**, was technically, legally and financially eligible and its bid was declared as the **Lowest Calculated Responsive Bid**;





WHEREAS, Section 34.4, Rule X of the Implementing Rules and Regulations of RA 9184 partly states that "If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all criteria for post qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of the contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower...xxx."


WHEREAS, the bid amount submitted by **RNS Construction and Engineering** is advantageous to the government vis-à-vis that of all the other bidders.


