**WHEREAS**, a public bidding was conducted on June 20, 2017, 9:00 o'clock in the morning at DA 12 Conference Room, Brgy. Carpenter Hill, Koronadal City for the project entitled "Supply and delivery of 144 head Goat" with an Approved Budget for the Contract (ABC) of Two Million One Hundred Sixty Thousand Pesos (Php2,160,000.00);

**WHEREAS**, there were two (2) bidders who submitted their letters of intent and sealed bids for the above-described project, to wit:

WHEREAS, during the Bid Evaluation Process, the BAC including its Technical Working Group (TWG) found out that the bid submitted by **Nordan Ngilay Espadila Live's Stock** in the amount of **One Million Eight Hundred Ninety Thousand Seven Hundred Twenty Pesos (Php1,890,720.00)** has met the minimum requirements and was determined as the **Lowest Calculated Bid**. Therefore, subjected for Post-Qualification;

WHEREAS, per the conduct of post-qualification process of all the submitted documents, it was determined that **Nordan Ngilay Espadila Live's Stock**, was found out post-disqualified due to non-compliance of the following requirements;

WHEREAS, Section 34.6, Rule X of RA 9184 states that, *"Immediately if the BAC has notified the first bidders of its post-disqualification, and notwithstanding any pending request for reconsideration thereof, the BAC shall initiate and complete the same post-qualification process on the bidder with the second Lowest Calculated Bid/Highest Rated Bid. If the second bidder passes the post-qualification, and provided that the request for reconsideration of the first bidder has been denied, the second bidder shall be post-qualified as the bidder with the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid;*

WHEREAS, the Bids and Awards Committee (BAC) notified **Nordan Ngilay Espadila Live's Stock** in writing dated **September 8, 2017** of its post-disqualification and the grounds for it which was received by the latter on **September 12, 2017**;

WHEREAS, within three (3) calendar days upon receipt of the Notice of Post-Disqualification, no Motion for Reconsideration filed by **Nordan Ngilay Espadila Live's Stock**


WHEREAS, the Bids and Awards Committee (BAC) initiated and completed the same post-qualification process on the bidder with the **second Lowest Calculated Bid** which was **PCS Livestock Ventures** in the amount of **One Million Nine Hundred Forty-Four Thousand Pesos (Php1,944,000.00)**;


WHEREAS, per post-qualification of all the submitted documents of **PCS Livestock Ventures**, it was determined that the latter was technically, legally and financially eligible and its bid was declared as the **Lowest Calculated Responsive Bid**;
