


WHEREAS, Section 34.4, Rule X of the Implementing Rules and Regulations of RA 9184 partly states that *"If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all criteria for post qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of the contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower...xxx."*

WHEREAS, the bid amount submitted by **John Ray Developer and Supplies** is advantageous to the government vis-à-vis that of all the other bidders.


