WHEREAS, a public bidding was conducted on August 29, 2017 9:00 o'clock in the morning at DA 12 Conference Room, Koronadal City, South Cotabato for the project entitled **Line item no. 3: Supply and Delivery of 250 cans Raddish** with an **Approved Budget for the Contract (ABC) of Two Hundred Fifty Thousand Pesos (Php250,000.00)**.

WHEREAS, there was only one (1) bidder who submitted its letter of intent and sealed bid for the above-described project, to wit;

WHEREAS, during the Bid Evaluation Process, the BAC including its Technical Working Group (TWG) found out that the bid submitted by **JTM Agrochem** in the amount of **One Hundred Fifty-One Thousand Nine Hundred Eighty-Four Pesos and 80/100 (Php151,984.80)** has met the minimum requirements and was determined as the **Single Calculated Bid**. Therefore, subjected for **Post-Qualification**;

WHEREAS, per the conduct of post-qualification process of all the submitted documents, it was determined that **JTM Agrochem**, was **technically, legally and financially eligible** and its bid was declared as the **Single Calculated and Responsive Bid**;

WHEREAS, Section 36, letter A, Rule X of RA 9184 states that "Xxx. A Single Calculated/Rated and Responsive Bid shall be considered for award if it falls under any of the following circumstances. Xxx."


"Xxx. If after advertisement only one prospective bidder submits a letter of intent and/or applies for an eligibility check in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; Xxx."


WHEREAS, Section 34.4, Rule X of the Implementing Rules and Regulations of RA 9184 partly states that "If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all criteria for post qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of the contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower...xxx."


