**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT FOR THE PROJECT ENTITLED SUPPLY AND DELIVERY OF 1 UNIT CORN PICKER WITH A BID PRICE OF THREE MILLION FOUR HUNDRED NINETY-FIVE THOUSAND PESOS (PHP3,495,000.00) REPRESENTING THE 100% AMOUNT OF THE PROJECT.**

**WHEREAS**, a public bidding was conducted on December 27, 2016, 9:00 o'clock in the morning at DA 12 Conference Room, for the project **Supply and Delivery of 1 Unit Corn Picker** with an **Approved Budget for the Contract (ABC) of Three Million Five Hundred Thousand Pesos (Php3,500,000.00)** as the **100% cost of the project**.

**WHEREAS**, there were two (2) bidders who submitted their letters of intent and sealed bids for the above-described project, to wit;

**WHEREAS**, during the Bid Evaluation Process, the BAC including its Technical Working Group (TWG) found out that the bid submitted by **Green Valley Machinery** in the amount of **Two Million Three Hundred Eighty Thousand Pesos (Php2,380,000.00)** representing the **100% of the project** has met the minimum requirements and was determined as the **Lowest Calculated Bid**. Therefore, subjected for Post-Qualification:

**WHEREAS**, per the conduct of post-qualification process of all the submitted documents, it was determined that **Green Valley Machinery**, was found out that the latter was post disqualified due to non-compliance of the following specifications;

**WHEREAS**, Section 34.6, Rule X of RA 9184 states that *"Immediately after the BAC has notified the first bidder of its post disqualification, and notwithstanding any pending request for reconsideration thereof, the BAC shall initiate and complete the same post-qualification process on the bidder with the second Lowest Calculated/Highest Rated Bid. If the second bidder passes the post-qualification, and provided that the request for consideration of the first bidder has been denied, the second bidder shall be post-qualified as the bidder with the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid."*

**WHEREAS**, the Bids and Awards Committee (BAC) immediately notified **Green Valley Machinery** in writing dated **February 20, 2017** of its post-disqualification and the grounds for it which was received by the latter on **February 23, 2017**.

**WHEREAS**, no motion for reconsideration was filed by **Green Valley Machinery** within three (3) calendar days upon receipt of the Notice of Post-Disqualification. Thus, the BAC initiated and completed the same qualification process on the bidder with the second Lowest Calculated Bid which was **Agri Component Corporation**.

**WHEREAS**, after thorough deliberation of the Bids and Awards Committee based on the evaluation reports of the Technical Working Group, it was found out that **Agri Component Corporation** met the minimum requirements of the Procuring Entity and its proposal in the amount of **Three Million Four Hundred Ninety-Five Thousand Pesos (Php3,495,000.00) representing the 100% of the project** and was determined the **Lowest Calculated Bid**. Therefore, subjected for Post-Qualification;

**WHEREAS**, per post-qualification of all the submitted documents of **Agri Component Corporation** it was determined that the latter was technically, legally and financially eligible and its bid was declared as the **Lowest Calculated Responsive Bid**;

**WHEREAS**, the project shall be **90/10% scheme wherein the Ninety percent (90%) amount of the project shall be paid by the procuring entity as DA's counterpart and the Ten Percent (10%) amount shall be the recipients equity**;

**WHEREAS**, after breakdown of bid tendered by **Agri Component Corporation** for the said project is shown below;
