WHEREAS, a public bidding was conducted on March 28, 2017, 9:00 o'clock in the morning at DA XII Conference Room, for the project entitled **Supply and Delivery of 6,615 Bags Various Hybrid Rice Seeds Particularly Line Item no. 1: Supply and Delivery of 1,101 Bags NSIC Rc 314H Hybrid Rice Seeds with an Approved Budget for the Contract (ABC) of Five Million Five Hundred Five Thousand Pesos (Php5,505,000.00).**

WHEREAS, there were three (3) bidders who submitted their letters of intent and sealed bids for the above-described project, to wit;

WHEREAS, during the Bid Evaluation Process, the BAC including its Technical Working Group (TWG) found out that the bid submitted by **PRC Marketing** in the amount of **Four Million Seven Hundred Thirty-Four Thousand Three Hundred Pesos (Php4,734,300.00)** has met the minimum requirements and was determined as the **Lowest Calculated Bid**. Therefore, subjected for Post-Qualification;

WHEREAS, per the conduct of post-qualification process of all the submitted documents, it was determined that **PRC Marketing**, was technically, legally and financially eligible and its bid was declared as the **Lowest Calculated Responsive Bid**;

WHEREAS, Section 34.4, Rule X of the Implementing Rules and Regulations of RA 9184 partly states that *"If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all criteria for post qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of the contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower...xxx."*

WHEREAS, the bid amount submitted by **PRC Marketing** is advantageous to the government vis-à-vis that of all the other bidders.

WHEREAS, A conduct of germination testing is required to determine the germination rate of the seeds to be supplied and delivered;

WHEREAS, should all or some of the seeds fail the above said germination test, the winning bidder shall replace the seeds to conform to the required specifications;


