**WHEREAS**, a public bidding was conducted on May 2, 2017, 9:00 o'clock in the morning at DA 12 Conference Room, for the project entitled **Construction of Four (4) units Coffee Roasting Facility** particularly **Line Item No.1: Construction of One (1) unit Coffee Roasting Facility** with an **Approved Budget for the Contract (ABC) of Six Hundred Ninety-Four Thousand Seven Hundred Thirty-Eight Pesos and 56/100 (Php694,738.56).**

**WHEREAS**, there was only one (1) bidder who submitted its letter of intent and sealed bid for the above-described project, to wit;

**WHEREAS**, during the Bid Evaluation Process, the BAC including its Technical Working Group (TWG) found out that the bid submitted by **Johnray Developer & Supplies** in the amount of **Six Hundred Forty-Three Thousand Eight Hundred Thirty-Eight Pesos and 15/100 (Php643,838.15)** has met the minimum requirements and was determined as the **Single Calculated Bid**. Therefore, subjected for Post-Qualification;

**WHEREAS**, per the conduct of post-qualification process of all the submitted documents, it was determined that **Johnray Developer & Supplies**, was technically, legally and financially eligible and its bid was declared as the **Single Calculated and Responsive Bid**;

**WHEREAS**, Section 36, letter A, Rule X of RA 9184 states that *"Xxx. A Single Calculated/Rated and Responsive Bid shall be considered for award if it falls under any of the following circumstances. Xxx."*

If after advertisement only one prospective bidder submits a letter of intent and/or applies for an eligibility check in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; Xxx."*







