WHEREAS, there were two (2) bidders who submitted their letters of intent and sealed bids for the above item, as follows:

WHEREAS, after thorough deliberation by the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), **LEADS Agricultural Products Corporation** (Leads for brevity) was declared as the bidder who submitted the Lowest Calculated Bid (LCB). However, during the post-qualification evaluation conducted by the Technical Working Group (TWG), it was declared **POST-DISQUALIFIED** per notice dated March 28, 2017. Attached is a copy of the said notice and form an integral part hereof.

WHEREAS, Leads did not file a request for consideration to the Notice of Post-Disqualification within the reglementary period to file, thus, the TWG then proceeded to the **Second Lowest Calculated Bid**, a joint venture between **Kooperatiba ng**

Magsasakang Pilipino ng Timog Kutabato (KOMATIKU) and Renel's Fruit Nursery with a bid amount of **FORTY-THREE MILLION FOUR HUNDRED THIRTY ONE THOUSAND SIX HUNDRED FORTY PESOS (Php43,431,640.00)**, in accordance with Section 23.1.b of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 which partly states;






