WHEREAS, a public bidding was conducted on May 2, 2017, 9:00 o'clock in the morning at DA 12 Conference Room, for the project entitled "**Line Item No. 2: Construction of 2 units Coffee Roasting Facility**" with an **Approved Budget for the Contract (ABC)** of **One Million Three Hundred Eighty-Nine Thousand Four Hundred Seventy-Seven Pesos and 12/100 (Php1,389,477.12)**.

WHEREAS, during the Bid Evaluation Process, the BAC including its Technical Working Group (TWG) found out that the bid submitted by **Cofejok Construction and Supply Corporation** in the amount of **One Million Three Hundred Eighty-Seven Thousand Three Hundred Fifty-Five Pesos and 80/100 (Php1,387,355.80)** has met the minimum requirements.
