**SENTINEL PLASTIC MANUFACTURING CORP.**, with principal address at **404 M. H. Del Pilar, Maysilo, District I, Malabon City** represented by **VIRGINIA L. CO**, Vice-President hereinafter called as the **Second Party**;

**WITNESSETH:**

**WHEREAS**, the **First Party** has a procurement for the **Supply and Delivery of 4,240 pcs. Plastic Crates** with an **Approved Budget for the Contract of Two Million One Hundred Twenty Thousand Pesos (Php2,120,000.00)**;

**WHEREAS**, a public bidding was conducted on February 14, 2017 with only one (1) participating bidder in which the project entitled **Supply and Delivery of 4,240 pcs. Plastic Crates** was awarded to **Sentinel Plastic Manufacturing Corp.** being the bidder with the **Single Calculated and Responsive Bid** in the amount of **Two Million Thirty-Five Thousand Two Hundred Pesos (Php2,035,200.00)**;

**WHEREAS**, the **First Party** has accepted the bid of the **Second Party** in the amount of **Two Million Thirty-Five Thousand Two Hundred Pesos (Php2,035,200.00)** which shall be completely delivered at **DA-Balindog RES, Kidapawan City** within **Forty-Five (45) calendar days** upon receipt of the approved Notice to Proceed with the following specifications, to wit:

1. The following documents shall be deemed to form and be read and construed as part of this agreement, viz.:
  - a) Funded and Approved Purchase Request;
  - b) Advertisement;
  - c) Approved Notice of Award;
  - d) Performance Bond;
  - e) Bid form and the price schedule submitted by the bidder.
  - f) Schedule of requirements
  - g) Abstract of Bids for Bid project;
  - h) Resolution of the Bids and Awards Committee as the case may be; and
  - i) Other pertinent documents as may be reasonable required by the First Party.
2. The **First Party** hereby covenants to pay the **Second Party** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
3. Should the **Second Party** incur delay, Section 68, Rule XXII of RA 9184, partly states, "xxx. *The amount of the liquidated damages shall be at least equal to one tenth (1/10) of one percent (1%) of the cost of the unperformed portion for every day of delay. xxx*";
4. The specific duties and responsibilities of the parties herein shall be embodied in a separate instrument.
5. Other provisions of RA 9184 and its IRR not stipulated in this contract shall form part of this agreement; and
6. This agreement shall be valid and binding upon signing by both parties.


