- Planting of robusta cutting under germination chamber for rooting purposes
- Watering, weeding and fertilization of germinated seeds & rooted robusta clones
- Fencing with nets and installation of sheds for the Arabica coffee seedbeds
- Maintenance of seedbeds and rooted cutting until ready for transplanting
- On polythelene bags
