INVITATION TO BID

The Department of Agriculture, Regional Field Office No. 12, Koronadal City through its Bids and Awards Committee (BAC) invites prospective and interested bidders for the procurement of the following projects, to wit:

1. 2,000 bags OPV Corn Seeds

- With DA-12 logo painted (6 inches in diameter)
- With Agri Pinoy Logo painted (13x8 inches)

- Delivery Period : 60 calendar days

- Purity rate : 95% and above

The bidding will be conducted through open competitive procedures using a non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184, otherwise known as the "Philippine Government Procurement Act".

Bid opening shall be on **June 24, 2014 at 02:pm** in the **DA-RFO 12 Conference Room, Zulueta Street, Koronadal City.**

Sealed Bids must be delivered/submitted to the DA-RFO 12 BAC Secretariat Office **on or before 02:00pm of June 24, 2014;**

Company's representatives must present their **Special Power of Attorney (SPA)** during the opening of the bidding;

Bids shall be accompanied by a bid security either of the following schedule:

- 1. Cash or Cashier's/Manager's check issued by a Universal or Commercial Bank
- 2% of the Approved Budget for the Contract (ABC)**
 - 2. Bank Guarantee
- 2% of the Approved Budget for the Contract (ABC)**
 - 3. Surety Bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security
- 5% of the Approved Budget for the Contract (ABC); or**
- 3. Bid Securing Declaration (duly notarized)**
