RESOLUTION FOR NEGOTIATED CONTRACT BY AND BETWEEN THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD OFFICE XII AND SUKI TRADING CORPORATION FOR THE SUPPLY AND DELIVERY OF 10 UNITS MULTI-COMMODITY DRYER WITH THE BID PRICE OF PHP2,380,000.00.

Whereas, the Department of Agriculture, Regional Field Office 12 under Agri Pinoy High Value Crops Development Program (HVCDP) CY 2014 has a procurement of Various Agricultural Supplies and Materials with the Approved Budget for the Contract (ABC) of Two Million Five Hundred Thousand Pesos (Php2,500,000.00);

Whereas, there were already two (02) failures of bidding for the said project per Resolution No. 2014-1259-A and 3015-060A dated November 25, 2014 and April 13, 2015 respectively;

Whereas, per Section 35, 35.5, Rule X of RA 9184 states that, "Should there occur a second failure of bidding, the Procuring Entity may resort to negotiated contract, as provided for in Section 53.1 of this IRR."

Whereas, the said project was published as Negotiated Procurement under Two-Failed Biddings in the Philippine Government Electronic Procurement System (PhilGEPS) last May 13, 2015.

Whereas, the Bids and Awards Committee (BAC) invited three (03) eligible bidders for the Negotiated Procurement of the said project, namely:

1. Suki Trading Corporation in Lapu-Lapu city, Cebu;

2. Winch Mechanical Innovations & General Construction, Inc. in General Santos City; and

3. J.O. Hinggo Trading Corporation in Davao City.

(Failed – no attached Bidder's Bond)

Whereas, in the opening of sealed bids for negotiated procurement conducted last May 25, 2015 - 10:00AM at the DA-RFO 12 Conference Room, Koronadal City, there were three (03) bidder submitted its Request for Expression of Interest (REOI) and sealed bids, namely:

Whereas, after the thorough deliberation of the Bids and Awards Committee (BAC) based on the evaluation and post-qualification reports of the Technical Working Group (TWG), it was found that Suki Trading Corporation met the minimum requirements of the Procuring Entity and was determined as the bidder who submitted the Lowest Calculated Responsive Bid;





WHEREFORE, premises considered, it is hereby RESOLVED to recommend to the Head of the Procuring Entity (HOPE) that the supply and delivery of 10 units Multi-Commodity Dryer in the amount of Two Million Three Hundred Eighty Thousand Pesos (Php2,380,000.00) be negotiated to Suki Trading Corporation as the bidder who submitted the Lowest Calculated Responsive Bid.
