RESOLUTION FOR NEGOTIATED CONTRACT BY AND BETWEEN THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD OFFICE XII AND KOOPERATIBA NG MAGSASAKANG PILIPINO SA TIMOG KUTABATO (KOMATIKU) FOR THE SUPPLY AND DELIVERY OF 26,000 KGS. PEANUT SEEDS WITH THE BID PRICE OF PHP1,553,541.60.

Whereas, the Department of Agriculture, Regional Field Office 12 under Agri Pinoy High Value Crops Development Program (HVCDP) CY 2014 has a procurement of **26,000 kgs. Peanut Seeds** with the **Approved Budget for the Contract (ABC) of One Million Five Hundred Sixty Thousand Pesos (Php1,560,000.00)**;

Whereas, there were already **two (02) failures of bidding** for the said project per **Resolution No. 001B and 002B** dated **January 12, 2015 and February 8, 2015**, respectively;

Whereas, per Section 35, 35.5, Rule X of RA 9184 states that, "*Should there occur a second failure of bidding, the Procuring Entity may resort to negotiated contract, as provided for in Section 53.1 of this IRR.*"

Whereas, the said project was published as **Negotiated Procurement under Two-Failed Biddings** in the Philippine Government Electronic Procurement System (PhilGEPS) last February 15, 2015.

Whereas, the Bids and Awards Committee (BAC) invited three (03) eligible bidders for the Negotiated Procurement of the said project; namely:

1. Kooperatiba ng Magsasakang Pilipino sa Timog Kutabato (KOMATIKU);
2. JMD Plant Nursery and Concrete Products; and
3. Touch Down Trading.

Whereas, in the opening of sealed bids for negotiated procurement conducted last February 27, 2015 - 9:00AM at the DA-RFO 12 Conference Room, Koronadal City, there was only one (01) bidder submitted its Request for Expression of Interest (REOI) and sealed bids, namely:


Whereas, after the thorough deliberation of the Bids and Awards Committee (BAC) based on the evaluation and post-qualification reports of the Technical Working Group (TWG), it was found that **Kooperatiba ng Magsasakang Pilipino sa Timog Kutabato (KOMATIKU)** met the minimum requirements of the Procuring Entity and was determined as the bidder who submitted the **Single Calculated and Responsive Bid**;


Whereas, Section 36 (a), Rule X of RA 9184 states that "A single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances: Xxx


a) If after advertisement, only one prospective bidder submits an LOI and/or applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; or Xxx"


WHEREFORE, premises considered, it is hereby RESOLVED to recommend to the Head of the Procuring Entity (HOPE) that the supply and delivery of 26,000 kgs. Peanut Seeds in the amount of One Million Five Hundred Fifty-Three Thousand Five Hundred Forty-One Pesos and 60/100 (Php1,553,541.60) be negotiated to Kooperatiba ng Magsasakang Pilipino sa Timog Kutabato (KOMATIKU) as the bidder who submitted the Single Calculated and Responsive Bid.






