RESOLUTION FOR NEGOTIATED CONTRACT BY AND BETWEEN THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD OFFICE XII AND KOOPERATIBA NG MAGSASAKANG PILIPINO SA TIMOG KUTABATO (KOMATIKU) FOR THE SUPPLY AND DELIVERY OF 83,825 PCS. BANANA PLANTING MATERIALS WITH THE BID PRICE OF PHP2,920,882.10.

Whereas, the Department of Agriculture, Regional Field Office 12 under Agri Pinoy High Value Crops Development Program (HVCDP) CY 2014 has a procurement of **83,825 pcs. Banana Planting Materials** with the **Approved Budget for the Contract (ABC) of Two Million Nine Hundred Thirty-Three Thousand Eight Hundred Seventy-Five Pesos (Php2,933,875.00)**;

Whereas, there were already **two (02) failures of bidding** for the said project per **Resolution No. 0010** and **0080** dated **January 12, 2015** and **February 9, 2015**, respectively;

Whereas, per Section 35, 35.5, Rule X of RA 9184 states that, "Should there occur a second failure of bidding, the Procuring Entity may resort to negotiated contract, as provided for in Section 53.1 of this IRR."

Whereas, the said project was published as **Negotiated Procurement under Two-Failed Biddings** in the Philippine Government Electronic Procurement System (PhilGEPS) last February 15, 2015.

Whereas, the Bids and Awards Committee (BAC) invited three (03) eligible bidders for the Negotiated Procurement of the said project, namely:

1. Kooperatiba ng Magsasakang Pilipino sa Timog Kutabato (KOMATIKU);
2. JMD Plant Nursery and Concrete Products; and
3. Touch Down Trading.

Whereas, in the opening of sealed bids for negotiated procurement conducted last February 27, 2015 - 9:00AM at the DA-RFO 12 Conference Room, Koronadal City, there was only one (01) bidder submitted its Request for Expression of Interest (REOI) and sealed bids, namely:

Whereas, after the thorough deliberation of the Bids and Awards Committee (BAC) based on the evaluation and post-qualification reports of the Technical Working Group (TWG), it was found that **Kooperatiba ng Magsasakang Pilipino sa Timog Kutabato (KOMATIKU)** met the minimum requirements of the Procuring Entity and was determined as the bidder who submitted the **Single Calculated and Responsive Bid**;

Whereas, Section 36 (a), Rule X of RA 9184 states that "A single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances: Xxx


a) If after advertisement, only one prospective bidder submits an LOI and/or applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; or Xxx"

Whereas, Section 34.4, Rule X of RA 9184 partly states that "If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of the contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, Xxx."


Whereas, the bid amount (as read) offered by **Kooperatiba ng Magsasakang Pilipino sa Timog Kutabato (KOMATIKU)** which is advantageous to the government is **Two Million Nine Hundred Twenty Thousand Eight Hundred Eighty-Two Pesos and 10/100 (Php2,920,882.10)**;


WHEREFORE, premises considered, it is hereby RESOLVED to recommend to the Head of the Procuring Entity (HOPE) that the **supply and delivery of 83,825 pcs. Banana Planting Materials** in the amount of **Two Million Nine Hundred Twenty Thousand Eight Hundred Eighty-Two Pesos and 10/100 (Php2,920,882.10)** be negotiated to **Kooperatiba ng Magsasakang Pilipino sa Timog Kutabato (KOMATIKU)** as the bidder who submitted the **Single Calculated and Responsive Bid**.




