RESOLUTION FOR NEGOTIATED CONTRACT BY AND BETWEEN THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD OFFICE XII AND PP PACKAGING FOR THE SUPPLY AND DELIVERY OF VARIOUS AGRICULTURAL SUPPLIES AND MATERIALS WITH THE BID PRICE OF PHP837,436.02.

Whereas, the Department of Agriculture, Regional Field Office 12 under Agri Pinoy High Value Crops Development Program (HVCDP) CY 2014 has a procurement of **Various Agricultural Supplies and Materials** with the **Approved Budget for the Contract (ABC) of Nine Hundred Sixty-Two Thousand Eight Hundred Eighty-Three Pesos and 25/100 (Php962,883.25)**;

Whereas, there were already **two (02) failures of bidding** for the said project per **Resolution No. 2015-146A and 2015-169A** dated May 4, 2015 and June 9, 2015, respectively;

Whereas, per Section 35, 35.5, Rule X of RA 9184 states that, "*Should there occur a second failure of bidding, the Procuring Entity may resort to negotiated contract, as provided for in Section 53.1 of this IRR.*"

Whereas, the said project was published as **Negotiated Procurement under Two-Failed Biddings** in the Philippine Government Electronic Procurement System (PhilGEPS) last June 08, 2015.

Whereas, the Bids and Awards Committee (BAC) invited three (03) eligible bidders for the Negotiated Procurement of the said project, namely:

1. PP Packaging in Meycauayan City, Bulacan;
2. JTM Agrochem in Koronadal City, South Cotabato; and
3. ALT Agricultural Supplies in Kidapawan City, North Cotabato.

Whereas, in the opening of sealed bids for negotiated procurement conducted last June 22, 2015 - 10:00AM at the DA-RFO 12 Conference Room, Koronadal City, there was only one (01) bidder submitted its Request for Expression of Interest (REOI) and sealed bids, namely :

Whereas, after the thorough deliberation of the Bids and Awards Committee (BAC) based on the evaluation and post-qualification reports of the Technical Working Group (TWG), it was found that **PP Packaging** met the minimum requirements of the Procuring Entity and was determined as the bidder who submitted the **Single Calculated and Responsive Bid**;

Whereas, Section 34.4, Rule X of RA 9184 partly states that "If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of the contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, Xxx."


Whereas, the bid amount offered by PP Packaging which is advantageous to the government is **Eight Hundred Thirty-Seven Thousand Four Hundred Thirty-Six Pesos and 02/100 (Php837,436.02)**;


Whereas, Section 36 (a), Rule X of RA 9184 states that "A single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances: Xxx


a) If after advertisement, only one prospective bidder submits an LOI and/or applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; or Xxx"

WHEREFORE, premises considered, it is hereby RESOLVED to recommend to the Head of the Procuring Entity (HOPE) that the **supply and delivery of Various Agricultural Supplies and Materials** in the amount of **Eight Hundred Thirty-Seven Thousand Four Hundred Thirty-Six Pesos and 02/100 (Php837,436.02)** be negotiated to PP Packaging as the bidder who submitted the **Single Calculated and Responsive Bid**.


