
Whereas, in the bidding conducted last January 12, 2015 at 10:00AM in the DA-RFO 12 Conference Room, there was no bidder submitted its bid.


Whereas, Section 35, 35.1 (a), Rule X of RA 9184 states that *"The BAC shall declare the bidding a failure when Xxx:*

(a) No bids are received, Xxx"




