Whereas, the Department of Agriculture, Regional Field Office 12 under the Agri-Pinoy High Value Crops Development Program (HVCDP) CY 2015 has a procurement of 83,825 pcs. Banana Planting Materials with the Approved Budget for the Contract (ABC) of Two Million Nine Hundred Thirty-Three Thousand Eight Hundred Seventy-Five Pesos (Php2,933,875.00);

Whereas, per Resolution No. <u>Dis-Olo</u> dated <u>January 12, 2015</u> the Bids and Awards Committee (BAC) declared a failure of bidding and a re-bidding with readvertisement shall be conducted;

Whereas, in the second (2nd) bidding conducted last February 09, 2015 at 10:00AM in the DA-RFO 12 Conference Room, there was still no bidder submitted its sealed bids.

Whereas, Section 35, 35.1 (a), Rule X of RA 9184 states that "The BAC shall declare the bidding a failure when.Xxx:

(a) No bids are received, Xxx"

Whereas, per Section 35, 35.5, Rule X of RA 9184 states that "Should there occur a second failure of bidding, the procuring entity may resort to negotiated procurement, as provided for in Section 53.1 of this IRR."

WHEREFORE, premises considered, it is hereby RESOLVED that the supply and delivery of 83,825 pcs. Banana Planting Materials with the ABC of Php2,933,875.00 shall be done through a Negotiated Procurement under Two-Failed Biddings.
