Whereas, the Department of Agriculture, Regional Field Office 12 under the Agri-Pinoy High Value Crops Development Program (HVCDP) CY 2015 has a procurement of 83,825 pcs. **Banana Planting Materials** with the **Approved Budget for the Contract (ABC)** of **Two Million Nine Hundred Thirty-Three Thousand Eight Hundred Seventy-Five Pesos (Php2,933,875.00)**;

Whereas, per Resolution No. 2015-0010 dated January 12, 2015 the Bids and Awards Committee (BAC) declared a failure of bidding and a re-bidding with re-advertisement shall be conducted;

Whereas, in the second (2nd) bidding conducted last February 09, 2015 at 10:00AM in the DA-RFO 12 Conference Room, there was still no bidder submitted its sealed bids.


Whereas, Section 35, 35.1 (a), Rule X of RA 9184 states that "*The BAC shall declare the bidding a failure when Xxx:*


(a) No bids are received, Xxx"


