## CONTRACT

This Contract made this of day of 2015 between **DEPARTMENT OF AGRICULTURE, REGIONAL FIELD OFFICE XII,** Koronadal City, Philippines, represented by its **Regional Executive Director, AMALIA J. DATUKAN, MBA** hereinafter called the **First Party**and **Suki Trading** corporation with principal address at Agus, Ibabao, Lapu-Lapu City, represented by its **Sales Engineer, Albert M. Dela Torre**, called the **Second Party**;

Whereas, the First Party invited Bids for certain goods viz., Ten (10) units Mobile Cassava Chipper cum Shredder and the bid has accepted by the Second Party for the supply of those goods in the sum of One Million Eighty Thousand Pesos (Php1,080,000.00), (hereinafter called "the Contract Price");

Whereas, the project is under the "Full Grant" scheme to be distributed to identified accredited recipients;

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to;
- 2. The following documents shall be deemed to form and be read and construed as part of this agreement, viz.:
  - (a) Funded and Approved Purchase Request;
  - (b) Advertisement;
  - (c) Technical and Financial documents of the supplier/contractor
  - (d) Performance Bond
  - (e) Abstract of Bid for Bid Project
  - (f) Resolution of the Bids and Awards Committee as the case may be
  - (g) Approval of the Award by the Regional Executive Director conformed by the Contractor/ Supplier
  - (h) Other pertinent documents as may be reasonable required by the First Party



3. The First Party hereby covenants to pay the Second Party in consideration of the provision of the goods and services and the remedying of defects therein, the contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

4. The Second Party hereby agrees to deliver the Ten (10) units Mobile Cassava Chipper cum Shredder to DA-Tupi, Bololmala, South Cotabato within sixty (60) calendar days upon receipt of the Notice to Proceed with the following specifications, to wit:

2000kg/hr (Shredder) Capacity 3000kg/hr capacity Cassava Granulator: 10 HP, air cooled Diesel Engine

With brand new tire no. 14 and tow bar

Shall be painted with Agri Pinoy and DA Logo (10" in diameter)

60 calendar days Delivery Period :

DA-CEMIARC, Bololmala, Tupi, South Cotabato Delivery Site

- 5. The Second Party hereby agrees to give demo and trainings for the recipients which shall be undertaken on the delivery site for 2 weeks or 1 month continuous operation before payment shall be made;
- 6. A warranty of one (1) year for the necessary repairs and maintenance including parts and services must be strictly observed. The obligation of warranty shall be covered by retention money, in an amount equivalent to ten percent (10%) of the total contract price, or a bank guarantee in a form of an irrevocable stand-by letter of credit.
- 7. Should the Second Party incur delay, Section 68, Rule XXII of RA 9184, partly states, "xxx. The amount of the liquidated damages shall be at least equal to one tenth (1/10) of one percent (1%) of the cost of the unperformed portion for every day of delay. xxx";
- 8. Other provisions of RA 9184 and its IRR not stipulated in this contract are deemed applicable; and
  - 9. This agreement shall be valid and binding upon approval of both parties.
