CONTRACT OF CONSTRUCTION

KNOW ALL MEN BY THESE PRESENT:

This contract made and entered this 6th day of September, 2014 by and between the **DEPARTMENT OF AGRICULTURE, REGIONAL FIELD Office 12, KORONADAL CITY**, represented by the **Regional Executive Director, AMALIA J. DATUKAN**, hereinafter called the **First Party** and **C.A. Betalac Construction and General Merchandise** with principal address at **Alunan Highway, Tacurong City** represented by its **Proprietor, ELNA S. BETALAC**, hereinafter called as the **Second Party**;

WITNESSETH

Whereas, the First Party has a project of **Concreting of Colindibus Main Canal, Colindibus, Columbio, Sultan Kudarat** with the approved budget for the contract of **Php3,000,000.00**;

Whereas, a public bidding was conducted last July 30, 2014 with two (2) participating bidder in which C. A. Betalac Construction and General Merchandise owned by **MS. ELNA S. BETALAC** was determined as the bidder who submitted a single calculated and responsive bid in the amount of **Two Million Nine Hundred Eighty-Four Thousand Nine Hundred Eighty-Six Pesos and 91/100 (Php2,984,986.91)**;

Whereas, the First Party has accepted the bid of the **Second Party** for the **Concreting of Colindibus Main Canal, Colindibus, Columbio, Sultan Kudarat** in the amount of **Two Million Nine Hundred Eighty-Four Thousand Nine Hundred Eighty-Six Pesos and 91/100 (Php2,984,986.91)** which shall be completed within **ninety (90) calendar days** with the following specifications and program of works, to wit:

NOW THEREFORE, for and in consideration of the following premises, the parties hereto agreed as follows:

1. The following documents shall be deemed to form and be interpreted/construed as part of this agreement, viz:

- Plans, designs, Program of works
- Specifications
- Advertisement
- License copy of the contractor
- Certificate of availability of funds

- f. Performance Bond
- g. Bids and Abstract of Bids for the project
- h. Resolution of the Bids and Awards Committee as the case may be
- i. Approval of the Award by the Regional Director
- j. Letter of Acceptance of the winning bidder
- k. Official Government estimates, by work item and cost components
- l. Duly approved program of works and estimates
- m. PERT/CPM of equivalent schedule of work
- n. Other pertinent documents as may be reasonable required by the First Party

2. In consideration of the payments to be made by **the First Party, the Second Party** hereby covenants/agrees with the Department of Agriculture to construct and complete the works in conformity with all aspects with the provisions of this contract;

3. The First Party hereby covenants to pay the 15% Mobilization fee of the total cost of the project to the Second Party as advance payment, upon compliance of the following:

- a.) **letter-request for 15% advance payment;**
- b.) **standby irrevocable letter of credit/security bond/bank guarantee which corresponds to the amount of the 15% mobilization fee;**
- c.) **Installation of project billboard;**
- d.) **construction of bunkhouse; and**
- e.) **Mobilization of initial equipment and personnel**

4. A warranty of one (1) year for the necessary repairs and maintenance including parts and services must be strictly observed. The obligation of warranty shall be covered by retention money, in an amount equivalent to ten percent (10%) of the total contract price, or a bank guarantee in a form of an irrevocable stand-by letter of credit. Said amount shall be released after the lapse of the warranty period;

5. Should the Second Party incur delay, Section 68, Rule XXII of RA 9184, party states, "Xxx. *The amount of the liquidated damages shall be at least equal to one tenth (1/10) of one percent (1%) of the cost of the unperformed portion for every day of delay. Xxx*";

6. Other provisions of RA 9184 and its IRR not stipulated in this contract are deemed applicable; and

7. This agreement shall be valid and binding upon approval of the First Party, in accordance with the provisions of R.A. 9184.






