



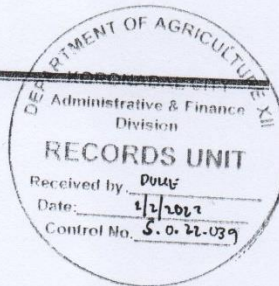


The term of office of the above-named personnel shall expire one (1) year upon its execution unless sooner removed, has resigned/retired, transferred or re-assigned.

Moreover, the members of said committee are entitled to a monthly honorarium which shall not exceed twenty-five percent (25%) of their respective basic salary in accordance with DBM Circular No. 2004-5A. However, such claim shall be on a pro rata basis depending on their attendance on various BAC deliberations and proceedings.

On the other hand, the members of the TWG shall perform their functions on an "on-call basis" depending on the technical expertise required in which case a memorandum inviting them shall be issued to such effect.

All personnel designated herein shall be on a "jury duty" type of assignment. The term shall be understood to mean that BAC proceedings/assignments shall be given utmost priority over all other duties and responsibilities.

This order shall take effect immediately and supersedes all issuances inconsistent herewith.
