RESOLUTION FOR NEGOTIATED CONTRACT BY AND BETWEEN THE DEPARTMENT OF AGRICULTURE - REGIONAL FIELD OFFICE NO. 12 AND SOUTH COTABATO, SEED PRODUCERS MPC FOR LINE ITEM NO. 2 : SUPPLY AND DELIVERY OF 5,882 BAGS CERTIFIED PALAY SEEDS WITH THE BID PRICE OF PHP7,998,720.05.

Whereas, the Department of Agriculture - Regional Field Office No. 12, Koronadal City under the Agri-Pinoy Rice Program CY 2015 Fund has a procurement, i.e.; **Supply and delivery of 11,953 bags Certified Palay Seeds** with the Total Approved Budget for the Contract (ABC) of **Sixteen Million Two Hundred Fifty-Six Thousand Eighty Pesos (Php16,256,080.00)**;

Whereas, there were already two (2) failures of bidding for the said project per Resolution No. 2015-431 and 2016-0015 dated December 28, 2015 and February 3, 2016, respectively;

Whereas, Section 35, 35.5, Rule X of RA 9184 states that *"Should there occur a second failure of bidding, the procuring entity may resort to negotiated procurement, as provided for in Section 53.1 of this IRR;*

Whereas, the said project was published as **Negotiated Procurement under Two-Failed Biddings** in the Philippine Government Electronic Procurement System (PhilGEPS) last February 9, 2016 using the **Line Item Method**, to wit:

Line Item No. 1 : Supply and delivery of 6,071 bags Certified Palay Seeds
(in support to *Technology Demonstration*)
ABC : Php8,256,560.00

Line Item No. 2 : Supply and delivery of 5,882 bags Certified Palay Seeds
(in support to *El Niño Mitigation*)
ABC : Php7,999,520.00

Whereas, the Bids and Awards Committee (BAC) invited three (3) eligible bidders for the Negotiated Procurement of the said two (2) projects, namely:

1. Davao Oriental Seed Producers Cooperative (DOSEPCO) in Davao Oriental;
2. South Cotabato Seed Producers MPC in Koronadal City; and
3. Central Isulan Multi-Purpose Cooperative in Isulan, Sultan Kudarat.

Whereas, in the opening of sealed bids for negotiated procurement conducted last February 22, 2016 - 10:00AM at DA-12 Conference Room, Koronadai City, there was only one (1) bidder submitted its Request for Extension of Interest (REOI) and sealed bids, naniely:

Whereas, after the thorough deliberation of the Bids and Awards Committee (BAC) based on the evaluation and post-qualification reports of the Technical Working Group (TWG), it was found that **South Cotabato Seed Producers MPC** met the minimum requirements of the Procuring Entity and was determined as the bidder who submitted the **Single Calculated and Responsive Bid**;

Whereas, Section 36 (a), Rule X of RA 9184 states that "A single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances:

- a) If after advertisement, only one prospective bidder submits an LOI and/or applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; or Xxx"

Whereas, Section 34, 34.4, Rule X of RA 9184 states that "If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower, xxx";

Whereas, the bid amount (as calculated) offered by **South Cotabato Seed Producers MPC** for the **Line Item No. 2 : Supply and delivery of 5,882 bags Certified Palay Seeds (in support to El Niño Mitigation)** which is advantageous to the government is **Seven Million Nine Hundred Ninety-Eight Thousand Seven Hundred Twenty Pesos and 05/100 (Php7,998,720.05)**;
