Whereas, the Department of Agriculture – Regional Field Office No. 12, Koronadal City under the SOCSKSARGEN Food Security Program CY 2016 Fund has a project, i.e.; **Concreting of Poblacion Columbio – Telefás FMR in Brgy. Poblacion, Columbio, Sultan Kudarat** with the Approved Budget for the Contract (ABC) of **Nineteen Million Three Hundred One Thousand Three Hundred Ninety-Five Pesos and 20/100 Only (Php19,301,395.20)**;

Whereas, a public bidding for the **Concreting of Poblacion Columbio – Telefás FMR in Brgy. Poblacion, Columbio, Sultan Kudarat** with the Approved Budget for the Contract (ABC) of **Nineteen Million Three Hundred One Thousand Three Hundred Ninety-Five Pesos and 20/100 Only (Php19,301,395.20)** was scheduled last February 9, 2016 – 9:00AM at DA-12 Conference Room, Koronadal City. It was presided by the BAC Chairman;

Whereas, the project shall be on 85/15 scheme wherein the **eighty-five percent (85%) cost of the project shall be charged to DA-RFO 12 SOCSKSARGEN Food Security Program CY 2016 Fund** and the **fifteen percent (15%) cost shall be the Provincial Local Government Unit (LGU) of Sultan Kudarat's counterpart** as shown below:
