Whereas, a public bidding was conducted last June 1, 2016 at 9:00 am in the DA-12 Conference Room, Brgy. Carpenter Hill, Koronadal City. It was presided by the BAC Chairman.

Whereas, there were three (3) bidders who submitted their letters of intent and sealed bids for the "supply and delivery of Various Fertilizer for Inbred Techno Demo" with the **Approved Budget for the Contract (ABC) of Three Million Two Hundred Sixty-Four Thousand Pesos (Php3,264,000.00)**, i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **JTM Agrochem** in the amount of **Two Million Five Hundred Ninety-Five Thousand Three Hundred Fifty Pesos and 40/100 (Php2,595,350.40)** met the minimum requirements and was determined as the **Lowest Calculated Bid**. Therefore, subjected for Post-Qualification;


Whereas, per post-qualification of all the submitted documents of **JTM Agrochem** it was determined that the latter was technically, legally and financially eligible and its bid was declared as the **Lowest Calculated Responsive Bid**;

Whereas, Section 34.4 Rule X of RA 9184 states that *"If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all criteria for post-qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower..... xxx"*


