**RESOLUTION FOR NEGOTIATED CONTRACT BY AND BETWEEN THE DEPARTMENT OF AGRICULTURE - REGIONAL FIELD OFFICE NO. 12 AND GREEN SEEDS GARDEN AND PLANTREES DEPOT TRADING FOR THE SUPPLY AND DELIVERY OF 200,000 PCS. COFFEE PLANTING MATERIALS (ROBUSTA - STEM CLONES) WITH THE BID PRICE OF PHP3,760,000.00.**

**Whereas**, the Department of Agriculture - Regional Field Office No. 12, Koronadal City under the Agri-Pinoy High Value Crops Development Program CY 2016 Fund has a procurement, i.e.; **Supply and delivery of 200,000 pcs. Coffee Planting Materials (Robusta-Stem Clones)** with the Approved Budget for the Contract (ABC) of **Four Million Pesos (Php4,000,000.00)**;

**Whereas**, there were already two (2) failures of bidding for the said project per Resolution No. 2015-0020 and 2015-007A dated January 12, 2015 and February 9, 2015, respectively;

**Whereas**, Section 35, 35.5, Rule X of RA 9184 states that *"Should there occur a second failure of bidding, the procuring entity may resort to negotiated procurement, as provided for in Section 53.1 of this IRR;*

**Whereas**, the said project was published as **Negotiated Procurement under Two-Failed Biddings** in the Philippine Government Electronic Procurement System (PhilGEPS) last March 10, 2016;

**Whereas**, the Bids and Awards Committee (BAC) invited three (3) eligible bidders for the Negotiated Procurement of the said project, namely:

1. Green Seeds Garden and Plantrees Depot Trading in Batangas;
2. HVCC Plant Nursery in Carmen, North Cotabato; and
3. Rene's Fruit Nursery in Davao City.

Whereas, in the opening of sealed bids for negotiated procurement conducted last March 21, 2016 – 10:00AM at DA-12 Conference Room, Koronadal City, there were two (2) bidders submitted its Request for Extension of Interest (REOI) and sealed bids, namely:

Whereas, after the thorough deliberation of the Bids and Awards Committee (BAC) based on the evaluation and post-qualification reports of the Technical Working Group (TWG), it was found that **Green Seeds Garden and Plantrees Depot Trading** met the minimum requirements of the Procuring Entity and was determined as the bidder who submitted the **Lowest Calculated Responsive Bid**;

Whereas, Section 36 (a), Rule X of RA 9184 states that "A single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances:


- a) If after advertisement, only one prospective bidder submits an LOI and/or applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; or xxx"


Whereas, Section 34, 34.4, Rule X of RA 9184 states that "If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower, xxx";


Whereas, the bid amount (as submitted) offered by **Green Seeds Garden and Plantrees Depot Trading** which is advantageous to the government is **Three Million Seven Hundred Sixty Thousand Pesos (Php3,760,000.00)**;


WHEREFORE, premises considered, it is hereby RESOLVED to recommend to the Head of the Procuring Entity (HOPE) that the supply and delivery of **200,000 pcs. Coffee Planting Materials (Robusta-Stem Clones)** in the amount of **Three Million Seven Hundred Sixty Thousand Pesos (Php3,760,000.00)** be negotiated to **Green Seeds Garden and Plantrees Depot Trading** as the bidder who submitted the **Lowest Calculated Responsive Bid**.


