**Whereas,** a public bidding for the procurement of **Forty-Five (45) Units Pump And Engine Set-Open Source** was scheduled last June 13, 2016 at 10:00 am. It was held in the Department of Agriculture, RFO 12 conference room, Brgy. Carpenter Hill, Koronadal City;

**Whereas,** the project has an Approved Budget for the Contract (ABC) of Four Million Five Hundred Thousand Pesos (Php4,500,000.00);

**Whereas,** there were six (6) bidders who submitted their letters of intent and sealed bids for the supply and delivery of **Forty-Five (45) Units Pump And Engine Set-Open Source**, namely:

**Whereas**, after thorough deliberations of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), it was determined that **Fortunetract Agro- Sales, Inc.** met the minimum requirements and was declared as the bidder who submitted the Lowest Calculated Bid and was subjected to Post-qualification;


**Whereas**, per post-qualification reports of the BAC and TWG, the bid of Fortunetract Agro Sales, Inc. in the amount of **Forty-Five (45) Units Pump and Engine Set-Open Source in the amount of Two Million Nine Hundred Two Thousand Four Hundred Ninety-Nine Pesos and 55/100 (Php2,902,499.55) at Sixty-Four Thousand Four Hundred Ninety-Nine Pesos And 99/100 (Php64,499.99) per unit** was declared as the Lowest Calculated Responsive Bid (LCRB);

**Whereas**, Section 34.4, Rule X of RA 9184 states that *"if the BAC determines that the bidder with the lowest calculated bid passes all the criteria for post-qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid and recommend to the Head of the Procuring Entity the award of the contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower"*;


