Whereas, a public bidding was conducted last June 01, 2016 at 9:00 am in the DA-RFO XII Conference Room, Koronadal City. It was presided by the BAC Chairman.

Whereas, there was only one (1) bidder who submitted its letter of intent and sealed bid for the **Construction of 350 sq.m. Warehouse/Cold Storage** with the **Approved Budget for the Contract (ABC) of Four Million Eight Hundred Thirty Nine Thousand Two Hundred Seventy - Nine Pesos & 10/100 (Php 4,839,279.91)**, i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Isulan ECT Construction & General Merchandise, Inc.** in the amount of **Four Million Seven Hundred Ninety Thousand Eight Hundred Eighty - Seven Pesos & 10/100 (Php4,790,887.10)** met the minimum requirements and was determined as a **Single Calculated Bid**. Therefore, subjected for Post-Qualification;

Whereas, per post-qualification of all the submitted documents of **Isulan ECT Construction & General Merchandise, Inc.** it was determined that the latter was technically, legally and financially eligible and its bid was declared as a **Single Calculated and Responsive Bid**;

Whereas, Section 36, letter a, Rule X of RA 9184 states that "A *single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances:*


- a. *If after advertisement only one prospective bidder submits a letter of intent and/or applies for an eligibility check in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; xxx"*

WHEREFORE, premises considered, it is hereby **RESOLVED** to recommend to the Head of the Procuring Entity (HOPE) that the **construction of 350sq.m. Warehouse/Cold Storage** in the amount of **Four Million Seven Hundred Ninety Thousand Eight Hundred Eighty - Seven Pesos & 10/100 (Php4,790,887.10)** which is the **Single Calculated and Responsive Bid**, be awarded to **Isulan ECT Construction & General Merchandise, Inc.**
