Whereas, a bidding for the **Supply and Delivery of 260 HEAD GOATS (65 HEAD BUCK-8-12 MOS. @ 15-18 KLS. AND 195 HEAD DOE 8-12 MOS. @ 15-18 KLS.)** with the Approved Budget for the Contract (ABC) of **One Million Forty Thousand Pesos (Php1,040,000.00)** was scheduled last February 3, 2016 at 9:00AM. It was held in Villa Amor Hotel, Koronadal City;

Whereas, there were two (02) bidders who submitted their letters of intent and sealed bids for the said project; namely:

Whereas, after the bid evaluation by the Bids and Awards Committee (BAC) and the Technical Working Group of all the technical and financial documents of the participating bidders, it was found out that **Nordan Ngilay Espadila Live's Stock** has submitted the lowest calculated bid in the amount of **Nine Hundred Nine Thousand Four Hundred Eighty Pesos (Php909,480.00)** and was subjected for Post-qualification.

Whereas, per Post-qualification of all the submitted Legal, Technical and Financial documents of **Nordan Ngilay Espadila Live's Stock**, it was declared that its bid was the **Lowest Calculated Responsive Bid**;


Whereas, Section 34.4, Rule X of RA 9184 states that "if the BAC determines that the bidder with the lowest calculated bid passes all the criteria for post-qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid and recommend to the Head of the Procuring Entity the award of the contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower";


Whereas, the Lowest Calculated Responsive Bid offered by **Nordan Ngilay Espadila Live's Stock** which is advantageous to the government is **Nine Hundred Nine Thousand Four Hundred Eighty Pesos (Php909,480.00)**;

WHEREFORE, premises considered, it is hereby **RESOLVED** to recommend to the Head of the Procuring Entity (HOPE) that the **Supply and Delivery of 260 head goats (65 head buck-8-12 mos. @ 15-18 kls. and 195 head doe 8-12 mos. @ 15-18 kls.)** in the amount of **Nine Hundred Nine Thousand Four Hundred Eighty Pesos (Php909,480.00)** as the **Lowest Calculated Responsive Bid**, be awarded to **Nordan Ngilay Espadila Live's Stock**.


