Whereas, the Department of Agriculture – Regional Field Office No. 12, Koronadal City under the SOCSKARGEN Food Security Program CY 2016 Fund has a project, i.e.; **Concreting of Lun Masla – Kinam FMR Phase II in Brgy. Lun Masla/Kinam, Malapatan, Sarangani Province** with the Approved Budget for the Contract (ABC) of **Twenty-Six Million Three Hundred Forty-Three Thousand Seven Hundred Three Pesos and 17/100 Only (Php26,343,703.17)**;

Whereas, a public bidding for the **Concreting of Lun Masla – Kinam FMR Phase II in Brgy. Lun Masla/Kinam, Malapatan, Sarangani Province** with the Approved Budget for the Contract (ABC) of **Twenty-Six Million Three Hundred Forty-Three Thousand Seven Hundred Three Pesos and 17/100 Only (Php26,343,703.17)** was scheduled last January 21, 2016 – 9:00AM at Villa Amor Hotel, General Santos Drive, Koronadal City. It was presided by the BAC Chairman;

Whereas, the project shall be on 85/15 scheme wherein the **eighty-five percent (85%) cost of the project shall be charged to DA-RFO 12 SOCSKARGEN Food Security Program CY 2016 Fund** and the **fifteen percent (15%) cost shall be the Provincial Local Government Unit (PLGU) of Sarangani's counterpart** as shown below:

DA-12 SOCSKARGEN Food Security Program (85%)	: Php22,392,147.69
PLGU Sarangani (15%)	: 3,951,555.48
Total Approved Budget for the Contract (ABC)	: Php26,343,703.17

Whereas, there were two (2) bidders who submitted their letters of intent and sealed bids for the **Concreting of Lun Masla – Kinam FMR Phase II in Brgy. Lun Masla/Kinam, Malapatan, Sarangani Province**, namely:

Whereas, in a public bidding conducted last January 21, 2016, **Freden Construction** has submitted the **Lowest Calculated Responsive Bid**;


