Whereas, a public bidding was conducted last December 28, 2015 at 9:00 am in the DA RFO 12 conference room, Zulueta Street, Koronadal City. It was presided by the BAC Chairman.

Whereas, the project for the "Supply and Delivery of 20,053 bags/packs Organic Fertilizers" with the Total Approved Budget for the Contract (ABC) of Six Million Fifteen Thousand Nine Hundred Pesos (Php6,015,900.00) was published in the Philippine Government Electronic Procurement System (PhilGEPS) under Line Item Method, thus, the two (2) line items were as follows:

- a. **Line Item No. 1 : Supply and Delivery of 10,000 bags Organic Fertilizers;**
ABC : Php3,000,000.00
- b. **Line Item No. 2 : Supply and Delivery of 10,053 packs Organic Fertilizers**
ABC : Php3,015,900.00

Whereas, there were three (3) bidders who submitted their letters of intent and sealed bids for **Line Item No. 1: Supply and Delivery of 10,000 bags Organic Fertilizers** with the **Approved Budget for the Contract (ABC) of Three Million Pesos (Php3,000,000.00)**, i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **GABS Agri Supply and Buy & Sell** in the amount of **Two Million Five Hundred Thousand Pesos (Php2,500,000.00)** met the minimum requirements and was determined as the **Lowest Calculated Bid**. Therefore, subjected for Post-Qualification;

Whereas, per post-qualification of all the submitted documents of **GABS Agri Supply and Buy & Sell** it was determined that the latter was technically, legally and financially eligible and its bid was declared as the **Lowest Calculated Responsive Bid**;

WHEREFORE, premises considered, it is hereby **RESOLVED** to recommend to the Head of the Procuring Entity (HOPE) that **Line Item No. 1: supply and delivery of 10,000 bags Organic Fertilizers** in the amount of **Two Million Five Hundred Thousand Pesos (Php2,500,000.00)** being the bidder with the **Lowest Calculated Responsive Bid**, be awarded to **GABS Agri Supply and Buy & Sell**.




