Whereas, a public bidding was conducted last May 24, 2016 at 9:00 am at DA-RFO 12 Conference Room, Regional Center, Brgy. Carpenter Hill, Koronadal City. It was presided by the BAC Chairman.

Whereas, the project has the **Approved Budget for the Contract (ABC) of Thirteen Million Five Hundred Thousand Pesos (Php13,500,000.00);**

Whereas, the procurement for the **Construction and Installation of Three (3) units Rice Processing Center I TOTAL** was published in the Philippine Government Electronic Procurement System (PhilGEPS) under **Line Item Method**, thus, the two (2) line items were as follows:

- a. Line Item No. 1: Construction of Three (3) units Warehouse and Concrete Rice Hull Bin
ABC : Php7,175,115.61
- b. Line Item No. 2: Delivery and Installation of Three (3) units Compact Rice Mill and Accessories
ABC : Php6,324,884.39

Whereas, there were two (2) bidders who submitted their letters of intent and sealed bids for the **Line Item No. 2: Delivery and Installation of Three (3) units Compact Rice Mill and Accessories** with the **Approved Budget for the Contract (ABC) of Six Million Three Hundred Twenty-Four Thousand Eight Hundred Eighty-Four Pesos and 39/100 (Php6,324,884.39)**, i.e.:
