Whereas, the Department of Agriculture – Regional Field Office No. 12, Koronadal City under the SOCSKSARGEN Food Security Program CY 2016 Fund has a project, i.e.; **Concreting of Banucagon – Gegikens FMR (Malagakit Section) in Brgy. Malagakit, Pigcawayan, North Cotabato** with the Approved Budget for the Contract (ABC) of **Twenty-Three Million Two Hundred Sixty-Two Thousand Eight Hundred Thirty-Seven Pesos and 90/100 (Php23,262,837.90)**;

Whereas, a public bidding for the **Concreting of Banucagon – Gegikens FMR (Malagakit Section) in Brgy. Malagakit, Pigcawayan, North Cotabato** with the Approved Budget for the Contract (ABC) of **Twenty-Three Million Two Hundred Sixty-Two Thousand Eight Hundred Thirty-Seven Pesos and 90/100 (Php23,262,837.90)** was scheduled last February 24, 2016 – 9:00AM at *Cinco Ninas Restaurant*, Koronadal City. It was presided by the BAC Chairman;

Whereas, the project shall be on **85/15 scheme** wherein the **eighty-five percent (85%) cost of the project shall be charged to DA-RFO 12 SOCSKSARGEN Food Security Program CY 2016 Fund** and the **fifteen percent (15%) cost shall be the Provincial Local Government Unit (PLGU) of North Cotabato's counterpart** as shown below:

**Whereas**, after the thorough deliberation of the Bids and Awards Committee (BAC) based on the evaluation and post-qualification reports of the Technical Working Group (TWG), it was found that **Better Work Construction** met the minimum requirements of the Procuring Entity and was determined as the bidder who submitted the **Single Calculated and Responsive Bid**;

**Whereas**, Section 36 (a), Rule X of RA 9184 states that "A single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances:


- a) *If after advertisement, only one prospective bidder submits an LOI and/or applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; or Xxx"*


**Whereas**, Section 34.4, Rule X of RA 9184 partly states that, "If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the Lowest Calculated and Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of the contract to the said bidder at its submitted bid price or its calculated bid price, **whichever is lower or, Xxx."**


**Whereas**, the bid amount (as submitted) offered by **Better Work Construction** which is advantageous to the government is **Twenty-Three Million Two Hundred Fifty-Eight Thousand Seven Hundred Twenty-Six Pesos and 13/100 Only (Php23,258,726.13)**;






Whereas, in a public bidding conducted last February 24, 2016, **Better Work Construction** has submitted the **Single Calculated and Responsive Bid**;
