Whereas, a public bidding was conducted last February 9, 2016 at 9:00 am in the DA-RFO12 Conference Room, Koronadal City. It was presided by the BAC Chairman.

Whereas, there was only one (1) bidder who submitted its letter of intent and sealed bid for the **Food Provision for the conduct of Farmer's Heart Day cum Mini Ulat sa Bayan** with the **Approved Budget for the Contract (ABC) of One Million Seven Hundred Sixteen Thousand Pesos (Php1,716,000.00)**, i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Department of Agriculture Employees and Farmers Multi-Purpose Cooperative (DAEFMPC)** in the amount of **One Million Three Hundred Twenty Thousand Pesos (Php1,320,000.00)** met the minimum requirements and was determined as a **Single Calculated Bid**. Therefore, subjected for Post-Qualification;

Whereas, per post-qualification of all the submitted documents of **Department of Agriculture Employees and Farmers Multi-Purpose Cooperative (DAEFMPC)** it was determined that the latter was technically, legally and financially eligible and its bid was declared as a **Single Calculated and Responsive Bid**;


Whereas, Section 36, letter a, Rule X of RA 9184 states that "A *single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances:*

- a. *If after advertisement only one prospective bidder submits a letter of intent and/or applies for an eligibility check in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; xxx"*


WHEREFORE, premises considered, it is hereby **RESOLVED** to recommend to the Head of the Procuring Entity (HOPE) that the **Food Provision for the conduct of Farmer's Heart Day cum Mini Ulat sa Bayan** in the amount of **One Million Three Hundred Twenty Thousand Pesos (Php1,320,000.00)** which is the **Single Calculated and Responsive Bid**, be awarded to **Department of Agriculture Employees and Farmers Multi-Purpose Cooperative (DAEFMPC)**.






