**RESOLUTION FOR NEGOTIATED CONTRACT BY AND BETWEEN THE DEPARTMENT OF AGRICULTURE - REGIONAL FIELD OFFICE NO. 12 AND SOUTH COTABATO SEED PRODUCERS MPC FOR THE SUPPLY AND DELIVERY OF 24,285 BAGS CERTIFIED PALAY SEEDS WITH THE BID PRICE OF PHP33,024,297.24.**

**Whereas**, the Department of Agriculture - Regional Field Office No. 12, Koronadal City under the Agri-Pinoy Rice Program CY 2016 Fund has a procurement, i.e.; **Supply and delivery of 24,285 bags Certified Palay Seeds (in support to HYTA Program 2016)** with the Approved Budget for the Contract (ABC) of **Thirty-Three Million Twenty-Seven Thousand Six Hundred Pesos (Php33,027,600.00)**;

**Whereas**, there were already **two (2) failures of bidding** for the said project per Resolution No. 2016-0011A and 2016-0017 dated January 5, 2016 and February 3, 2016, respectively;

**Whereas**, Section 35, 35.5, Rule X of RA 9184 states that **"Should there occur a second failure of bidding, the procuring entity may resort to negotiated procurement, as provided for in Section 53.1 of this IRR;**

**Whereas**, the said project was published as **Negotiated Procurement under Two-Failed Biddings** in the Philippine Government Electronic Procurement System (PhilGEPS) last February 9, 2016;

**Whereas**, the Bids and Awards Committee (BAC) invited three (3) eligible bidders for the Negotiated Procurement of the said project, namely:

1. Davao Oriental Seed Producers Cooperative (DOSEPCO) in Davao Oriental;
2. South Cotabato Seed Producers MPC in Koronadal City; and
3. Central Isulan Multi-Purpose Cooperative in Isulan, Sultan Kudarat.

**Whereas**, in the opening of sealed bids for negotiated procurement conducted last February 22, 2016 - 10:00AM at DA-12 Conference Room, Koronadal City, there was only one (1) bidder submitted its Request for Extension of Interest (REOI) and sealed bids, namely:

Whereas, after the thorough deliberation of the Bids and Awards Committee (BAC) based on the evaluation and post-qualification reports of the Technical Working Group (TWG), it was found that **South Cotabato Seed Producers MPC** met the minimum requirements of the Procuring Entity and was determined as the bidder who submitted the **Single Calculated and Responsive Bid**;

Whereas, Section 36 (a), Rule X of RA 9184 states that "A single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances:

- a) If after advertisement, only one prospective bidder submits an LOI and/or applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; or Xxx"


Whereas, Section 34, 34.4, Rule X of RA 9184 states that "If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower, xxx";

Whereas, the bid amount (as calculated) offered by **South Cotabato Seed Producers MPC** which is advantageous to the government is **Thirty-Three Million Twenty-Four Thousand Two Hundred Ninety-Seven Pesos and 24/100 (Php33,024,297.24)**;


WHEREFORE, premises considered, it is hereby RESOLVED to recommend to the Head of the Procuring Entity (HOPE) that the supply and delivery of 24,285 bags Certified Palay Seeds (in support to HYTA Program 2016) in the amount of **Thirty-Three Million Twenty-Four Thousand Two Hundred Ninety-Seven Pesos and 24/100 (Php33,024,297.24)** be negotiated to **South Cotabato Seed Producers MPC** as the bidder who submitted the **Single Calculated and Responsive Bid**.


