**Whereas**, a public bidding was conducted last August 16, 2016 at 9:00 am in the DA-12 Conference Room, Brgy. Carpenter Hill, Koronadal City. It was presided by the BAC Chairman.

**Whereas**, there were two (2) bidders who submitted their letters of intent and sealed bids for the “**supply and delivery of Various Fertilizers**” with the **Approved Budget for the Contract (ABC) of Seven Million Three Hundred Fifty Thousand Pesos (Php7,350,000.00)**, i.e.:

**Whereas**, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Modern Time Enterprises, Inc.** in the amount of **Five Million Three Hundred Seventy-Six Thousand Four Hundred Fifty-Seven Pesos (Php5,376,457.00)** met the minimum requirements and was determined as the **Lowest Calculated Bid**.
