**Whereas**, a public bidding was scheduled last January 5, 2016 at 9:00 am. It was held in the Department of Agriculture, RFO 12 conference room, Zulueta Street, Koronadal City. It was presided by the BAC Chairman;

**Whereas**, there was only one (1) bidder who submitted its letter of intent and sealed bid for the **supply and delivery of Eight (8) units Four Wheel Drive Tractor with Backhoe** with the **Approved Budget for the Contract (ABC) of Thirteen Million Four Hundred Eighty Thousand Pesos (Php13,480,000.00)** as the 100% cost of the project, i.e.:

**Whereas**, after thorough deliberation of the bids and awards committee based on the evaluation reports of the technical working group, it was found out that **Filholland Corporation** met the minimum requirements of the Procuring Entity and its proposal in the amount of **Thirteen Million Two Hundred Eighty Thousand Nine Hundred Sixty Pesos (Php13,280,960.00)** representing the **100% amount of the project** and was determined the **Single Calculated Bid**. Therefore, subjected for Post-Qualification;

**Whereas**, per post-qualification of all the submitted documents of **Filholland Corporation** it was determined that the latter was technically, legally and financially eligible and its bid was declared as **Single Calculated and Responsive Bid**;

**Whereas**, Section 34.4 Rule X of RA 9184 states that *"If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all criteria for post-qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower..... xxx"*

Whereas, the bid amount submitted by **Filholland Corporation** which is advantageous to the government is **Thirteen Million Two Hundred Eighty Thousand Nine Hundred Sixty Pesos (Php13,280,960.00)** representing the **100% amount of the project**;

Whereas, the project shall be on **90/10% scheme wherein the Ninety percent (90%) amount of the project** shall be paid by the procuring entity as **DA's counterpart** and the **Ten percent (10%) amount shall be the recipient's equity**;

Whereas, the breakdown of bid tendered by **Filholland Corporation** for the said project is shown below;

Whereas, the **90%** amount of the project in the amount of **Eleven Million Nine Hundred Fifty-Two Thousand Eight Hundred Sixty-Four Pesos (Php11,952,864.00)** at **One Million Four Hundred Ninety-Four Thousand One Hundred Eight Pesos (Php1,494,108.00)** per unit shall be paid by the DA-RFO 12 as its counterpart;

Whereas, the Recipients' equity shall be **One Million Three Hundred Twenty-Eight Thousand Ninety-Six Pesos (Php1,328,096.00)** at **One Hundred Sixty-Six Thousand Twelve Pesos (Php166,012.00)** per unit representing the **Ten percent (10%)** amount of the project;


