Whereas, a public bidding was conducted last March 23, 2016 at 9:00 am in the DA RFO XII Conference Hall, Carpenter Hill, Koronadal City. It was presided by the BAC Chairman.

Whereas, there was only one (1) bidder who submitted its letter of intent and sealed bid for the **supply and delivery of Various Equipment** with the **Approved Budget for the Contract (ABC) of Five Hundred Twenty-Four Thousand Pesos (Php524,000.00)**, i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Printcomp Marketing** in the amount of **Five Hundred Twenty-Three Thousand Eight Hundred Eighteen Pesos (Php523,818.00)** met the minimum requirements and was determined as a **Single Calculated Bid**. Therefore, subjected for Post-Qualification;

Whereas, per post-qualification of all the submitted documents of **Printcomp Marketing** it was determined that the latter was technically, legally and financially eligible and its bid was declared as a **Single Calculated and Responsive Bid**;


Whereas, Section 36, letter a, Rule X of RA 9184 states that "A single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances:

- a. If after advertisement only one prospective bidder submits a letter of intent and/or applies for an eligibility check in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; xxx"

WHEREFORE, premises considered, it is hereby **RESOLVED** to recommend to the Head of the Procuring Entity (HOPE) that the **supply and delivery of Various Equipment** in the amount of **Five Hundred Twenty-Three Thousand Eight Hundred Eighteen Pesos (Php523,818.00)** which is the **Single Calculated and Responsive Bid**, be awarded to **Printcomp Marketing**.






