Whereas, a public bidding was conducted last February 4, 2016 at 9:00 am in the Villa Amor Hotel, Koronadal City. It was presided by the BAC Chairman.

Whereas, there were two (2) bidders who submitted their letters of intent and sealed bids for the **supply and delivery of 666,667 pcs Cacao Planting Materials** with the **Approved Budget for the Contract (ABC) of Sixteen Million Six Hundred Sixty-Six Thousand Six Hundred Seventy-Five Pesos (Php16,666,675.00)**, i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Binahon Agroforestry Farm** in the amount of **Thirteen Million Three Hundred Thousand Six Pesos and 60/100 (Php13,300,006.60)** met the minimum requirements and was determined as the **Lowest Calculated Bid**. Therefore, subjected for Post-Qualification;

Whereas, per post-qualification of all the submitted documents of **Binahon Agroforestry Farm** it was determined that the latter was technically, legally and financially eligible and its bid was declared as the **Lowest Calculated Responsive Bid**:


Whereas, Section 34.4 Rule X of RA 9184 states that **"If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all criteria for post-qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower..... xxx"**

Whereas, the bid amount submitted by **Binahon Agroforestry Farm** which is advantageous to the government is **Thirteen Million Three Hundred Thousand Six Pesos and 60/100 (Php13,300,006.60)**;


WHEREFORE, premises considered, it is hereby **RESOLVED** to recommend to the Head of the Procuring Entity (HOPE) that the **supply and delivery of 666,667 pcs Cacao Planting Materials** in the amount of **Thirteen Million Three Hundred Thousand Six Pesos and 60/100 (Php13,300,006.60)** which is the **Lowest Calculated Responsive Bid**, be awarded to **Binahon Agroforestry Farm**.






