**Whereas**, a public bidding was conducted last February 4, 2016 at 9:00 am in the Villa Amor Hotel, Koronadal City. It was presided by the BAC Chairman.

**Whereas**, there was only one (1) bidder who submitted its letter of intent and sealed bid for the **supply and delivery of Various Equipment for the Calamansi Juice Processing** with the **Approved Budget for the Contract (ABC) of Nine Hundred Ninety-Eight Thousand Pesos (Php998,000.00)**, i.e.:

**Whereas**, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Shock and Awe Trading** in the amount of **Nine Hundred Forty-Five Thousand Pesos (Php945,000.00)** met the minimum requirements and was determined as the **Single Calculated Bid**. Therefore, subjected for Post-Qualification;

**Whereas**, per post-qualification of all the submitted documents of **Shock and Awe Trading** it was determined that the latter was technically, legally and financially eligible and its bid was declared as the **Single Calculated and Responsive Bid**;


**Whereas, Section 36, letter a, Rule X of RA 9184 states that "A single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances:**

- a. *If after advertisement only one prospective bidder submits a letter of intent and/or applies for an eligibility check in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; xxx"*

**WHEREFORE, premises considered, it is hereby RESOLVED to recommend to the Head of the Procuring Entity (HOPE) that the supply and delivery of Various Equipment for the Calamansi Juice Processing in the amount of Nine Hundred Forty-Five Thousand Pesos (Php945,000.00) which is the Single Calculated and Responsive Bid, be awarded to Shock and Awe Trading.**


