Whereas, a public bidding was conducted last February 3, 2016 at 9:00 am in the Villa Amor Hotel, Koronadal City. It was presided by the BAC Chairman.

Whereas, there were four (4) bidders who submitted their letters of intent and sealed bids for the **supply and delivery of Twenty-Two (22) units Vacuum Pack Sealer** with the **Approved Budget for the Contract (ABC)** of **One Million Forty-Five Thousand Pesos (Php1,045,000.00)**, i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Shock and Awe Trading** in the amount of **Nine Hundred Ninety Thousand Pesos (Php990,000.00)** met the minimum requirements and was determined as the **Lowest Calculated Bid**. Therefore, subjected for Post-Qualification;

Whereas, per post-qualification of all the submitted documents of **Shock and Awe Trading** it was determined that the latter was technically, legally and financially eligible and its bid was declared as the **Lowest Calculated Responsive Bid**;


Whereas, Section 34.4 Rule X of RA 9184 states that *"If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all criteria for post-qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower..... xxx"*

Whereas, the bid amount submitted by Shock and Awe Trading which is advantageous to the government is **Nine Hundred Ninety Thousand Pesos (Php990,000.00)**;

WHEREFORE, premises considered, it is hereby **RESOLVED** to recommend to the Head of the Procuring Entity (HOPE) that the **supply and delivery of Twenty-Two (22) units Vacuum Pack Sealer** in the amount of **Nine Hundred Ninety Thousand Pesos (Php990,000.00)** which is the **Lowest Calculated Responsive Bid**, be awarded to **Shock and Awe Trading**.


