**Whereas**, a public bidding was conducted last August 16, 2016 at 9:00 am in the DA-12 Conference Room, Brgy. Carpenter Hill, Koronadal City. It was presided by the BAC Chairman.

**Whereas**, there was only one (1) bidder who submitted its letter of intent and sealed bid for the "supply and delivery of 2,831 bags Hybrid Rice Seeds" with the Approved Budget for the Contract (ABC) of Eleven Million Three Hundred Twenty-Four Thousand Pesos (Php11,324,000.00), i.e.:

**Whereas**, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Seedworks Philippines, Incorporated** in the amount of **Eleven Million Two Hundred Sixty-Three Thousand Four Hundred Sixteen Pesos and 60/100 (Php11,263,416.60)** met the minimum requirements and was determined as **Single Calculated Bid**. Therefore, subjected for Post-Qualification;


**Whereas**, per post-qualification of all the submitted documents of **Seedworks Philippines, Incorporated** it was determined that the latter was technically, legally and financially eligible and its bid was declared as a **Single Calculated and Responsive Bid**;

Whereas, Section 34.4 Rule X of RA 9184 states that **"If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all criteria for post-qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower..... xxx"**


