RESOLUTION FOR NEGOTIATED CONTRACT BY AND BETWEEN THE DEPARTMENT OF AGRICULTURE - REGIONAL FIELD OFFICE NO. 12 AND SOUTH COTABATO SEED PRODUCERS MULTI-PURPOSE COOPERATIVE FOR THE SUPPLY AND DELIVERY OF 24,285 BAGS CERTIFIED PALAY SEEDS (in support to HYTA Program 2016) WITH THE BID PRICE OF PHP33,027,600.00.

Whereas, the Department of Agriculture - Regional Field Office No. 12, Koronadal City under the Agri-Pinoy Rice Program CY 2016 Fund has a procurement, i.e.; **Supply and delivery of 24,285 bags Certified Palay Seeds (in support to HYTA Program 2016)** with the Approved Budget for the Contract (ABC) of **Thirty-Three Million Twenty-Seven Thousand Six Hundred Pesos (Php33,027,600.00)**;

Whereas, there were already **two (2) failures of bidding** for the said project per Resolution No. 2016-0028 and 2016-0136 dated March 14, 2016 and May 3, 2016, respectively;

Whereas, Section 35, 35.5, Rule X of RA 9184 states that **"Should there occur a second failure of bidding, the procuring entity may resort to negotiated procurement, as provided for in Section 53.1 of this IRR;**

Whereas, the said project was published as **Negotiated Procurement under Two-Failed Biddings** in the Philippine Government Electronic Procurement System (PhilGEPS) last May 14, 2016;

Whereas, the Bids and Awards Committee (BAC) invited three (3) eligible bidders for the Negotiated Procurement of the said project, namely:

1. South Cotabato Seed Producers MPC in Koronadal City.
2. S2R Producers Cooperative in Davao Oriental; and
3. South Nueva Ecija Seed Growers Multi-Purpose Cooperative in Nueva Ecija

Whereas, in the opening of sealed bids for negotiated procurement conducted last May 25, 2016 - 09:00AM at DA-12 Conference Room, Koronadal City, there was only one (1) bidder submitted its Request for Extension of Interest (REOI) and sealed bids, namely:

Whereas, after the thorough deliberation of the Bids and Awards Committee (BAC) based on the evaluation and post-qualification reports of the Technical Working Group (TWG), it was found that **South Cotabato Seed Producers Multi-Purpose Cooperative** met the minimum requirements of the Procuring Entity and was determined as the bidder who submitted the **Single Calculated and Responsive Bid**;

Whereas, Section 36 (a), Rule X of RA 9184 states that "A single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances:


- a) *If after advertisement, only one prospective bidder submits an LOI and/or applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; or Xxx"*


WHEREFORE, premises considered, it is hereby RESOLVED to recommend to the Head of the Procuring Entity (HOPE) that the **supply and delivery of 24,285 bags Certified Palay Seeds (in support to HYTA Program 2016)** in the amount of **Thirty-Three Million Twenty-Seven Thousand Six Hundred Pesos and 24/100 (Php33,027,600.00)** be negotiated to **South Cotabato Seed Producer Multi-Purpose Cooperative** as the bidder who submitted the **Single Calculated and Responsive Bid**.


