Whereas, a public bidding was conducted last September 27, 2016 at 9:00 am in the DA-12 Conference Room, Brgy. Carpenter Hill, Koronadal City. It was presided by the BAC Chairman.

Whereas, there was only one (1) bidder who submitted its letter of intent and sealed bid for the "supply and delivery of Vegetable Seeds" with the **Approved Budget for the Contract (ABC) of One Million Eight Hundred Sixty-Four Thousand Eight Hundred Pesos (Php1,864,800.00)**, i.e.:

Whereas, after thorough deliberation of the Bids and Awards Committee (BAC) and the Technical Working Group (TWG), the bid submitted by **Seedworks Philippines, Incorporated** in the amount of **One Million Eight Hundred Thirty-Two Thousand Three Hundred Thirty-Eight Pesos and 35/100 (Php1,832,338.35)** met the minimum requirements and was determined as **Single Calculated Bid**. Therefore, subjected for Post-Qualification;


Whereas, per post-qualification of all the submitted documents of **Seedworks Philippines, Incorporated** it was determined that the latter was technically, legally and financially eligible and its bid was declared as a **Single Calculated and Responsive Bid**;

Whereas, Section 34.4 Rule X of RA 9184 states that *"If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all criteria for post-qualification, it shall declare the said bid as the Lowest Calculated Responsive Bid/Highest Rated Responsive Bid, and recommend to the Head of the Procuring Entity the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower..... xxx"*


Whereas, the bid amount submitted by **Seedworks Philippines, Incorporated** which is advantageous to the government is **One Million Eight Hundred Thirty-Two Thousand Three Hundred Thirty-Eight Pesos and 35/100 (Php1,832,338.35)**;

WHEREFORE, premises considered, it is hereby **RESOLVED** to recommend to the Head of the Procuring Entity (HOPE) that the **supply and delivery of Vegetable Seeds** in the amount of **One Million Eight Hundred Thirty-Two Thousand Three Hundred Thirty-Eight Pesos and 35/100 (Php1,832,338.35)** which is a **Single Calculated and Responsive Bid**, be awarded to **Seedworks Philippines, Incorporated**.


